The meeting opened at 7.00 p.m.

#### Present

Also present was Ms Lanchester of the AA and Speedwatch and the clerk Mr M Mortimer.

#### 1 Election of Chair

Mr Hewitt was unanimously elected as Chair and Mr Traynier as Vice Chair

#### 6 Report from County Councillor

Mr Spratt sent his apologies.

#### 8 Highways/Chicken Farm Traffic

Mr Hewitt asked for a mandate to pursue the matter of the route of farm traffic with Breckland Council with an initial view of arranging a meeting with the parties involved. It was agreed that he could pursue the matter.

#### 11 Finance

The clerk reported that Mrs Harris was prepared to continue with the existing arrangement and it was agreed to do so.

#### 13 Recruitment

Mr Hewitt drew attention to the growing workload for councillors and stressed the need for new recruits to the parish council. Several councillors suggested they may know people who might be willing.

#### 14 Any Other Matters

Mr Traynier provided a document showing the findings of the latest speed camera recordings and informed the meeting that in future patterns of speeding might be detected. Mr Traynier and Ms Lanchester of Speedwatch agreed that PC Squires was proving helpful. Ms Lanchester told councillors that 3 new Speedwatch sites were being established.

Parking at the school was raised with much concern over safety. Mr Hewitt explained that he had been looking at arrangements in other areas. It was agreed that further consideration was essential and that it would be useful if the police could get involved. Mr Kemp supported Mr Hewitt's suggestion that all those concerned should get together.

Mr Kemp expressed frustration at the apparent futility of the work councillors did when nothing seemed to result from it. Several councillors agreed and sympathised especially as Mr Kemp had done so much in several aspects of parish business.

Ms Lanchester and Mr Kemp agreed to meet to discuss various matters concerning the allotments.

The meeting closed at 8.35. The next meeting will be on the 5th of June at St Andrew's.
