# 642 Bressingham and Fersfield Parish Council Minutes of the Meeting held on the 27<sup>th</sup> October 2025

#### 2 Declaration of Interests

### 3 To agree the minutes of the 22<sup>nd</sup> of September

#### **Public Speaking Time**

There was a report of a missing sign on the footpath off Common Road resulting in walkers ending up on private property. Mrs Farstad McKeown offered to pursue the matter. Mr Edwards offered to look for some signs to purchase.

### 5 Report from County Councillor

Dr Rowett reported on the deluge of energy projects leading to a round of consultations. On local government reform she stated that NCC had voted for a single authority for Norfolk and for the acceptance of a mayor for Norfolk and Suffolk. She invited applications for what remained of her personal councillor fund. The full report is in the minute book and on the website

#### 6 Report from District Councillor

Mr Easter sent his apologies and a report which had been circulated to councillors. It produced no comment or discussion and a copy is on the website and in the minute book.

#### 7 Emergency Plan

Mrs Farstad McKeown had circulated a preliminary draft plan as a basis for discussion and awaiting details. Miss Lanchester explained that the public event had provided some useful ideas. Several views were expressed by councillors on essentials and priorities were expressed but there was agreement that a list of vulnerable people should made. The possibility of setting up an Emergency Team separate from the PC was raised. Councillors agreed to give consideration to the development of the plan.

#### 8 Communications

The clerk reported two calls regarding dumping on the airfield but after a tour with Mr Edwards found nothing new. Mr Le Grys explained that he had already responded to the request for comments on the Norwich to Tilbury pylons.

Mrs Farstad McKeown wondered if the PC had a biodiversity plan and felt it should. She asked if it was a requirement to have one and Miss Lanchester stated that it was a requirement to have one or a Nature Plan.

## 14 Any Other Matters

Mrs Barton spoke about the disappearance of signs and the dumping of toxic waste. The clerk agreed to report the waste to South Norfolk.

Mr Le Grys announced that he would be resigning shortly.
